ABOUT DHAREEBA



Dhareeba is a new tax portal by General Tax Authority – Qatar for managing your tax matters online. Dhareeba is a simple but more robust tax tool with additional level of automation, authorisation and work integration.

In order to access Dhareeba, the authorized representative's registration with National Authorization System – NAS is mandatory. You need to ensure that the mobile number registered with MOCI for authorized representative is readily available for ensuring quick Dhareeba registration.

Failure to register your business by 30 September 2020, could result in penalty which may be easily avoided **if you follow the simple "Steps 1 to 6" given in next section**.

Should you have any doubts, our tax team at MSPartner is always at your service to get through with your registration successfully.
